

Unveiling — Connecting Past and Present

The high point of this historical event came with the unveiling of the Gray Rider. The honor went to two of the oldest surviving retired Troopers who were able to attend — Trooper Charles A. Hall, 86 years of age who served from May 16, 1928 to October 23, 1969 and Senior Investigator Lewis W. Johnson, 87 years of age who served from April 1, 1927 to December 31, 1969 — and three representatives of 170th Session of the State Police Academy, which made a substantial collective contribution to the Gray Rider its class project, Tpr. Thomas R. Ward, Tpr. Andrea L. Hughes and Tpr. Drew T. Billingslea. Together, linking past and present, they unveiled the Gray Rider.


